Proposed Increase in Capacity at Green Park School

Community School and Local Authority Details

School Details:

Green Park School, Green Park Avenue, Stowlawn, Bilston, West Midlands, WV14 6EH.

Local Authority Details:

City of Wolverhampton Council (Contact: Civic Centre, St Peter's Square, Wolverhampton, WV1 1RL).

Description of Alteration

It is proposed that the designated capacity of Green Park School is increased from 108 places to 144 places with effect from 1 September 2019.

Evidence of Demand

Green Park School is currently designated as a community special school with a capacity of 108. The school caters for pupils aged 3-19 with Severe Learning Difficulties (SLD) and Profound and Multiple Learning Difficulties (PMLD).

In recent years, levels of demand for Green Park School have increased significantly; consequently, numbers on roll at the school have increased from 107 in 2013/2014 to 132 in 2018/2019 (a 23% increase).

In recent years, numbers on roll at the school have exceeded the registered capacity of the school.

To cater for anticipated demand, the Council has commissioned 144 places at Green Park School for the 2019-20 academic year.

To support this temporary uplift in capacity, the Council is currently working closely with the school and partners to develop and deliver an appropriate capital scheme to meet pupils' needs in September 2019. It should be noted that the current capital investment needs to be recognised as providing capacity to cater for a temporary uplift in capacity in 2019/2020 until, and dependent upon, a final decision on the proposed permanent expansion being made.

Objectives (including how the proposal would increase educational standards and parental choice)

The prescribed alteration is proposed to enable Green Park School to permanently cater for a greater number of pupils.

The creation of additional capacity within this popular and successful school would provide extra places to meet an increasing level of demand in the City.

In December 2015, Green Park School was judged by Ofsted to be a Good school. Ofsted recognised that, "Leaders and Governors know the school well. They have high expectations of staff and pupils and demonstrate the capacity to improve the school further." (Ofsted 2016).

By increasing the capacity of Green Park School there would be greater opportunity for parental choice to be reflected in placement decisions.

The effect on other schools, academies and educational institutions within the area

The proposed prescribed alteration would introduce additional capacity into the City's local offer and maximise the opportunity for pupils to access appropriate local provision. A detrimental impact on other schools, academies and educational institutions is not anticipated.

Project costs and indication of how these will be met, including how long term value for money will be achieved

Central Government has committed capital funding (through the Special Provision Capital Fund) to help local authorities to create new school places and improve existing facilities for children and young people with special educational needs and/or disabilities. In March 2019, the City of Wolverhampton Council considered the outcome of consultation on the investment priorities for the future use of this funding, endorsed the identified investment priorities for the use of this grant funding and approved the allocation of resources to a new capital project at Green Park School.

The proposed prescribed alteration is expected to support long-term value for money by reducing the potential need for expensive out of city placements.

Implementation Plan

The proposed date for implementation is 1 September 2019.

The school's latest Ofsted report states that, "Teaching arrangements and the range of subjects on offer have been regularly checked since the last inspection, and they have been adapted to meet the needs of the pupils." "The best teaching in the school is characterised by careful planning, which provides challenge for pupils of all abilities. Teachers and teaching assistants work well together and teachers have a clear overview of what all pupils are learning." "The range of subjects is designed to deepen pupils' knowledge, understanding and skills." "Children in the early years enjoy very high-quality teaching, which is responsive to their needs in a stimulating and safe environment. The broad range of subjects provide rich, varied and imaginative experiences leading to high rates of progress." "Pupils behave well in class and around the school.
