

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that on 13 December 2022 Wolverhampton City Council made the following Orders under Sections 1, 2, 3, 84 and 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The effect of the Orders which comes into operation on 16 December 2022 is as follows:

1. THE WOLVERHAMPTON CITY COUNCIL (BILSTON)(PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 1) ORDER 2022

This Order will prohibit any vehicle to:

- (i) wait at any time on any day in parts of Cleveland Road; Gordon Street; Steelhouse Lane; Sutherland Place; Vicarage Road; Neville Patten Gardens;
- (ii) wait at any time on any day and to load and unload at any time on any day in parts of Cleveland Road; Gordon Street; Granville Street; Jenner Street; Steelhouse Lane; Sutherland Place; Neville Patten Gardens; and
- (iii) wait for a period longer than 20 minutes with no return within 1 hour in part of Cleveland Road.

Existing traffic regulation orders are hereby revoked to the extent necessary to facilitate the provisions of this Order.

2. THE WOLVERHAMPTON CITY COUNCIL (SUTHERLAND PLACE AND NEVILLE PATTEN GARDENS (20 MPH SPEED LIMIT) ORDER 2022

This Order will prohibit any person to drive any vehicle with a maximum speed exceeding 20 miles per hour on the lengths of roads specified in the Schedule below:

SCHEDULE

1. Neville Patten Gardens In its entirety from its junction with Cleveland Road.
2. Sutherland Place In its entirety from its junction with Steelhouse Lane.

3. THE WOLVERHAMPTON CITY COUNCIL (GORDON STREET) (PROHIBITION OF DRIVING FOR ALL MOTOR VEHICLES) ORDER 2022

This Order will prohibit any motor vehicle to proceed along that length of road as specified in the Schedule below:

SCHEDULE

1. Gordon Street From a point 63 metres east of the eastern kerb line of Granville Street for a distance of 1 metres in an eastern direction.

4. THE WOLVERHAMPTON CITY COUNCIL (SUTHERLAND PLACE) (PROHIBITION OF DRIVING FOR ALL MOTOR VEHICLES) ORDER 2022

This Order will prohibit any motor vehicle to proceed along that length of road as specified in the Schedule below:

SCHEDULE

1. Sutherland Place From a point 2 metres east of the eastern kerb line of Vicarage Road for a distance of 24 metres in an eastern direction.

Any person who wishes to question the validity of the Orders, on the grounds that it is not within the powers of the relevant section of the Act or on the ground that any requirement of those sections of the Act or of Parts I to III to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 13 December 2022 make an application for the purpose to the High Court.
