

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that on 31 October 2023 Wolverhampton City Council made the following Order under Sections 1, 2, and 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The effect of the Order which come into operation on 2 November 2023 are as follows:

THE WOLVERHAMPTON CITY COUNCIL (CITY CENTRE - PUBLIC REALM PHASE 3) (CIVIC AND WULFRUN HALLS) EVENT ORDER 2023

1. This Order will prohibit any vehicle to enter or proceed in any length of road specified in Schedule 1 for a period commencing 1.5 hours prior to the start of an event at either the Civic or Wulfrun Halls until 1.5 hours after the end of the event or such other time periods specified by the Council in their absolute discretion, decide that the restriction should apply.
2. This Order will prohibit any vehicle to stop or remain at rest in any length of road specified in Schedule 2 at any time on an event day or such other time periods specified by the Council in their absolute discretion.
3. The Wolverhampton City Council (Public Realm Phase 3) (One Way Traffic, Mandatory Turns and Prohibition of Motor Vehicles) Order 2021, together with any other Existing Traffic Regulation Orders are suspended to the extents necessary to facilitate all provisions of this order.
4. Two Way Traffic
On Event days, for the duration of the Prohibition of Vehicles specified in Schedule 1 of this order One Way traffic on the roads specified in Schedule 3 to this order, is hereby suspended.
5. The Borough of Wolverhampton (Town Centre) (General Traffic Control) Order 1990 is hereby revoked to the extent required to accommodate this order.

Any person who wishes to question the validity of the Order(s), on the ground(s) that it is not within the powers of the relevant section of the Act or on the ground(s) that any requirement of those sections of the Act or of Parts I to III of Schedule 9 to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 15 November 2023 make application for the purpose to the High Court.
