

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that on 17 January 2023 Wolverhampton City Council made the following Orders under Sections 1, 2, 84 and 124(1)(d) of the Road Traffic Regulation Act 1984. The effect of the Orders which comes into operation on 20 January 2023 is as follows:

1. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 13) ORDER 2022

This Order will prohibit any vehicle to:

- (i) wait at any time on any day in parts of Ward Street; Kenley Avenue; Kirton Place; Kirkwall Crescent; Hendon Avenue; Duxford Grove; Pembrey Gardens; Turnhouse Crescent; Uxbridge Close; Colerne Street; Leconfield Wharf; Hawkinge Close; Filton Place; Warmwell Drive; Coltishall Grove; Tangmere Road; Detling Drive; Usworth Close;
- (ii) wait at any time on any day and to load and unload at any time on any day in parts of Ettingshall Road; Kenley Avenue; Kirton Place; Kirkwall Crescent; Coningsby Drive; Hendon Avenue; Duxford Grove; Rockford Place; Malling Gardens; Pembrey Gardens; Exeter Gardens; Northolt Drive; Turnhouse Crescent; Detling Drive; Ward Street; Colerne Street; Tangmere Road; Usworth Close; Sidwick Crescent; and
- (iii) stop between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday on school entrance markings in parts of Tangmere Road

2. THE WOLVERHAMPTON CITY COUNCIL (WARD STREET AND ETTINGSHALL ROAD ESTATE) (20 MPH SPEED LIMIT) ORDER 2022

This Order will prohibit any person to drive any vehicle with a maximum speed exceeding 20 miles per hour on the lengths of roads specified in the Schedule below:

| 9. Pembrey Gardens | In its entirety from its junctions with Rockford Place, Northolt Drive. |
| 10. Exeter Gardens | In its entirety from its junctions with Coningsby Drive, Northolt Drive. |
| 11. Northolt Drive | In its entirety from its junctions with Ward Street, Turnhouse Crescent, Pembrey Gardens, Coningsby Drive, Exeter Gardens, Malling Gardens. |
| 12. Turnhouse Crescent | In its entirety from its junctions with Detling Drive, Northolt Drive. |
| 13. Detling Drive | In its entirety from its junctions with Ward Street, Uxbridge Close, Turnhouse Crescent. |
| 14. Uxbridge Close | In its entirety from its junction with Detling Drive. |
| 15. Ward Street | From its junctions with Usworth Close, Tangmere Road, Northolt Drive, Detland Drive, Colerne Street. |
| 16. Colerne Street | In its entirety from its junctions with Ward Street, Warmwell Drive, Leconfield Wharf, Filton Place, Hawkinge Close. |
| 17. Leconfield Wharf | In its entirety from its junction with Colerne Street. |
| 18. Hawkinge Close | In its entirety from its junction with Colerne Street. |
| 19. Filton Place | In its entirety from its junction with Colerne Street. |
| 20. Warmwell Drive | In its entirety from its junctions with Coltishall Grove, Colerne Street, Tangmere Road. |
| 21. Coltishall Grove | In its entirety from its junction with Warmwell Drive. |
| 22. Tangmere Road | In its entirety from its junctions with Ward Street, Warmwell Drive. |
| 23. Usworth Close | In its entirety from its junction with Ward Street. |
