

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that on 21 June 2022 Wolverhampton City Council made the following Orders under Sections 1, 2 and 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The effect of the Orders which comes into operation on 24 June 2022 is as follows:

1. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 10) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day in parts of Bank Street, Salop Street, Highfields Road and Bankfield Road.

2. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 11) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Dudley Road.

Existing traffic regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

3. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 9) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day in parts of Regent Street and Dover Street.

4. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 6) ORDER 2022

This Order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Dresden Close, Hilton Road, Spring Road; and
- (ii) stop between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday on school entrance markings in parts of Dresden Close.

5. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 8) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day in parts of D'Urberville Road.

6. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 7) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Briar Wood Close, Hincks Street and Thorne Street.

7. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 5) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Bath Street (Bilston) and Brook Street.

8. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 3) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day in parts of Overfield Drive and Capponfield Close.

9. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 4) ORDER 2022

This Order will prohibit any vehicle to:

- (i) wait between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Green Park Avenue; and
- (ii) stop between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday on school entrance markings in parts of Green Park Avenue.

Any person who wishes to question the validity of the Order, on the grounds that it is not within the powers of the relevant section of the Act or on the ground that any requirement of those sections of the Act or of Parts I to III and IV of Schedule 9 to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 21 June 2022 make application for the purpose to the High Court.
