

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that on 13 July 2021 Wolverhampton City Council made the following Orders under sections 1, 2 and 124(1) (d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The effect of the Orders which come into operation on 16 July 2021 are as follows:

1. The Wolverhampton City Council (City Centre) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 1) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in part of Castle Street.
Existing traffic regulation orders will be revoked to the extent necessary to facilitate the provisions of this Order.

2. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 2) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in parts of Butts Road and St Catherines Crescent.

3. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 3) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in parts of Wychbury Road and Adams Road.

4. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 4) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in parts of Riley Crescent and Coalway Road.

5. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 5) Order 2021

This Order will prohibit any vehicle to:

- (i) wait between 8am to 9am and 3pm to 4pm Monday to Friday and to load and unload between 8am to 9am and 3pm to 4pm Monday to Friday in parts of Church Hill and Vicarage Road;
- (ii) wait at any time on any day and to load and unload at any time on any day in parts of Vicarage Road, Wheathill Close, Church Hill and Pennwood Lane;

6. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 6) Order 2021

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Jeremy Road, Rosemary Crescent West and Park Avenue.

7. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 7) Order 2021

This Order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Cherry Street;
- (ii) wait at any time on any day in parts of Cherry Street;
- (iii) wait between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8am to 9.30pm and 2.30pm to 4.30pm Monday to Friday in parts of Cherry Street;
- (iv) wait for a period longer than 2 hours with no return within 2 hours between 8am to 5pm Monday to Friday in parts of Cherry Street;

8. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 8) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in parts of Lea Manor Drive and Church Hill.

9. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 9) Order 2021

This Order will prohibit any vehicle to:

- (i) wait between 7.30am to 9.30am and 3pm to 6pm Monday to Friday and to load and unload between 7.30am to 9.30am and 3pm to 6pm Monday to Friday in parts of Claremont Road and Claremont Mews;
- (ii) wait at any time on any day and to load and unload at any time on any day in parts of Claremont Road and Claremont Mews;

10. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 10) Order 2021

This Order will prohibit any vehicle to:

- (i) wait between 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Linden Lea;
- (ii) wait at any time on any day and to load and unload at any time on any day in parts of Linden Lea, Walnut Drive and Finchdene Grove;

11. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 11) Order 2021

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Pencombe Drive; Park Hall Road and Broadstone Close.

Any person who wishes to question the validity of the Order(s), on the ground(s) that it is not within the powers of the relevant section of the Act or on the ground(s) that any requirement of those sections of the Act or of Parts I to III of Schedule 9 to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 13 July 2021 make application for the purpose to the High Court.
