

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that on 25th March 2025 Wolverhampton City Council made the following Orders under Sections 1, 2, 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

1. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 3) ORDER 2024

The effect of the Orders which comes into operation on 16th May 2025 is as follows:

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Old Fallings Crescent and Walda Drive as specified on the Plan.

2. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 8) ORDER 2024

The effect of the Orders which comes into operation on 18th April 2025 is as follows:

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Ettingshall Road and Sweetbriar Road as specified on the Plan.

3. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 1) ORDER 2024

The effect of the Orders which comes into operation on 31st March 2025 is as follows:

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Stafford Road (Service Road) (Tettenhall) as specified on the Plan.

4. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2024

The effect of the Orders which comes into operation on 18th April 2025 is as follows:

This Order will prohibit any vehicle to

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Sandmere Rise;
- (ii) wait at any time on any day in parts of Sandmere Rise;

Any person who wishes to question the validity of the Orders, on the grounds that it is not within the powers of the relevant section of the Act or on the ground that any requirement of those sections of the Act or of Parts I to III and IV of Schedule 9 to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 25 March 2025 make an application for the purpose to the High Court.
