

# PUBLIC NOTICE

**NOTICE IS HEREBY GIVEN** that on 8 December 2020 Wolverhampton City Council made the following Orders under Sections 1, 2, 84 and 124(1)(d) of the Road Traffic Regulation Act 1984. The effect of the Orders which come into operation on 11 December 2020 are as follows:

**1. The Wolverhampton City Council (Penn) (Prohibition and Restriction of Waiting and Street Parking Places)(Amendment No 13) Order 2019**

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Glade Gardens, North Green and Warstones Drive.

**2. The Wolverhampton City Council (Bilston) (Prohibition and Restriction of Waiting and Street Parking Places)(Amendment No 13) Order 2019**

This Order will prohibit any vehicle to :

- (i) wait at any time on any day in parts of Lowick Drive and Prosser Street;
- (ii) wait at any time on any day and to load and unload at any time on any day in parts of Ambergate Road, Babbington Drive, Bagshaw Close, Broad Lanes, Cairnhill Drive, Coseley Road, Elswick Close, Highfields Road, Ladymoor Road, Lowick Drive, Montagu Drive, Norman Davies Gardens and Welldale Grove.

An existing traffic regulation order regarding Prosser Street will be revoked to the extent necessary to facilitate the provisions of this Order.

**3. The Wolverhampton City Council (Bilston Urban Village) (20 mph Speed Limit) Order 2019**

This Order will prohibit any person from driving any vehicle with a maximum speed exceeding 20 miles per hour on lengths of the roads on Ambergate Road, Babbington Drive, Bagshaw Close, Cairnhill Drive, Cardowen Place, Chaman Lal Gardens, Elswick Close, Lowick Drive, Montagu Drive, Norman Davies Gardens and Welldale Grove

**4. The Wolverhampton City Council (Bilston Urban Village) (7.5 Tonnes Weight Restriction) Order 2019**

This Order will prohibit any person from driving any vehicle with a maximum gross weight exceeding 7.5 tonnes to proceed in lengths of the roads on Ambergate Road, Babbington Drive, Bagshaw Close, Cairnhill Drive, Cardowen Place, Chaman Lal Gardens, Elswick Close, Lowick Drive, Montagu Drive, Norman Davies Gardens and Welldale Grove.

**5. The Wolverhampton City Council (Bilston Urban Village) (Verge and Footway Parking) Order 2019**

This Order will prohibit any vehicle to stop or wait at any time with one or more wheels on any part of the verge or footway in Ambergate Road.

**6. The Wolverhampton City Council (Wednesfield) (Prohibition and Restriction of Waiting and Street Parking Places)(Amendment No 1) Order 2020**

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Lakefield Road, Lancaster Drive, Bernard Hall Avenue, John Sills Road, Victor Meade Drive, Gordon Rabbetts Crescent, Reginald Smith Crescent, Vincent Southworth Drive, Jennie Lee Avenue and Green Meadow.

**7. The Wolverhampton City Council (Lancaster Drive Area) (20 mph Speed Limit) Order 2020**

This Order will prohibit any person from driving any vehicle with a maximum speed exceeding 20 miles per hour on lengths of the roads on Bernard Hall Avenue, John Sills Road, Lancaster Drive, Victor Meade Drive, Gordon Rabbetts Crescent, Reginald Smith Crescent, Vincent Southworth Drive and Ronald O Donnell Gardens.

**8. The Wolverhampton City Council (Wednesfield) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 3) Order 2020**

This Order will prohibit any vehicle to wait at any time on any day in parts of Vicarage Road.

Any person who wishes to question the validity of the Order(s), on the ground(s) that it is not within the powers of the relevant section of the Act or on the ground(s) that any requirement of those sections of the Act or of Parts I to III of Schedule 9 to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 8 December 2020 make application for the purpose to the High Court.
