

THE WOLVERHAMPTON CITY COUNCIL (GOODYEAR ESTATE)

(20 MPH SPEED LIMIT) ORDER 2020

Wolverhampton City Council in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 having given public notice in accordance with sub-section (2) of that section and having consulted with the Chief Officer of Police in accordance with paragraph 20 of part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order shall come into operation on the *19th February 2021* and may be cited as the Wolverhampton City Council (Goodyear Estate) (20 mph Speed Limit) Order 2020.
2. No person shall drive any vehicle with a maximum speed exceeding 20 miles per hour on the lengths of roads specified in the Schedule.

SCHEDULE

1. Hermes Close In its entirety from its junctions with Bushbury Lane and Seiberling Drive.
2. Indianapolis Gardens In its entirety from its junctions with Daytona Grove, Mallory Road, Brands Hatch Gardens and Seiberling Drive.
3. Daytona Grove In its entirety from its junctions with Indianapolis Gardens and Mallory Road.
4. Mallory Road In its entirety from its junctions with Indianapolis Gardens, Brands Hatch Gardens, Daytona Grove, Seiberling Drive, Le Mans Gardens and Silverstone Drive.
5. Brands Hatch Gardens In its entirety from its junctions with Mallory Road and Indianapolis Gardens.
6. Seiberling Drive In its entirety from its junctions with Hermes Close, Indianapolis Gardens, Goodwood Drive, Le Mans Gardens and Mallory Road.
7. Le Mans Gardens In its entirety from its junctions with Seiberling Drive and Mallory Road.
8. Silverstone Drive In its entirety from its junctions with Goodwood Drive, Mallory Road and Donnington Grove.
9. Donnington Grove In its entirety from its junctions with Silverstone Drive and Mercury Drive.

10. Goodwood Drive In its entirety from its junctions with Seiberling Drive, Silverstone Drive, Rockingham Close, Oulton Drive, Cadwell Crescent, Thrupton Avenue, Croft Gardens and Ranger Drive.
11. Rockingham Close In its entirety from its junction with Goodwood Drive.
12. Oulton Drive In its entirety from its junctions with Goodwood Drive, Knockhill Gardens and Mercury Drive.
13. Knockhill Gardens In its entirety from its junctions with Oulton Drive and Cadwell Crescent.
14. Mercury Drive In its entirety from its junctions with Donnington Grove, Oulton Drive, Akron Drive, Columbia Crescent and Cadwell Crescent.
15. Cadwell Crescent In its entirety from its junctions with Knockhill Gardens, Goodwood Drive, Mercury Drive and Columbia Crescent.
16. Columbia Crescent In its entirety from its junctions with Mercury Drive, Cadwell Crescent, Resolute Drive, Thrupton Avenue, Reliance Place, Croft Gardens and Ranger Drive.
17. Thrupton Avenue In its entirety from its junctions with Columbia Crescent, Goodwood Drive and Snetterton Gardens.
18. Snetterton Gardens In its entirety from its junction with Thrupton Avenue.
19. Resolute Drive In its entirety from its junctions with Akron Drive and Columbia Crescent.
20. Reliance Place In its entirety from its junctions with Akron Drive and Columbia Crescent.
21. Croft Gardens In its entirety from its junctions with Columbia Crescent and Goodwood Drive.
22. Ranger Drive In its entirety from its junctions with Goodwood Drive, Columbia Crescent, Akron Drive, Ohio Gardens, Macon Grove, Enterprise Crescent, Mayflower Gardens, Rainbow Avenue and Europa Gardens.
23. Ohio Gardens In its entirety from its junctions with Ranger Drive and Macon Grove.
24. Macon Grove In its entirety from its junctions with Ranger Drive, Akron Drive and Ohio Gardens.
25. Enterprise Crescent In its entirety from its junctions with Ranger Drive and Akron Drive.
26. Mayflower Gardens In its entirety from its junctions with Ranger Drive and Akron Drive.

- 27. Rainbow Avenue In its entirety from its junctions with Ranger Drive and Akron Drive.
- 28. Europa Gardens In its entirety from its junctions with Ranger Drive and Akron Drive.
- 29. Akron Drive In its entirety from its junctions with Mercury Drive, Europa Gardens, Rainbow Avenue, Mayflower Gardens, Macon Grove, Ranger Drive, Reliance Place, Resolute Drive and Enterprise Crescent.
- 30. Brooklands Close In its entirety from its junction with Goodwood Drive.

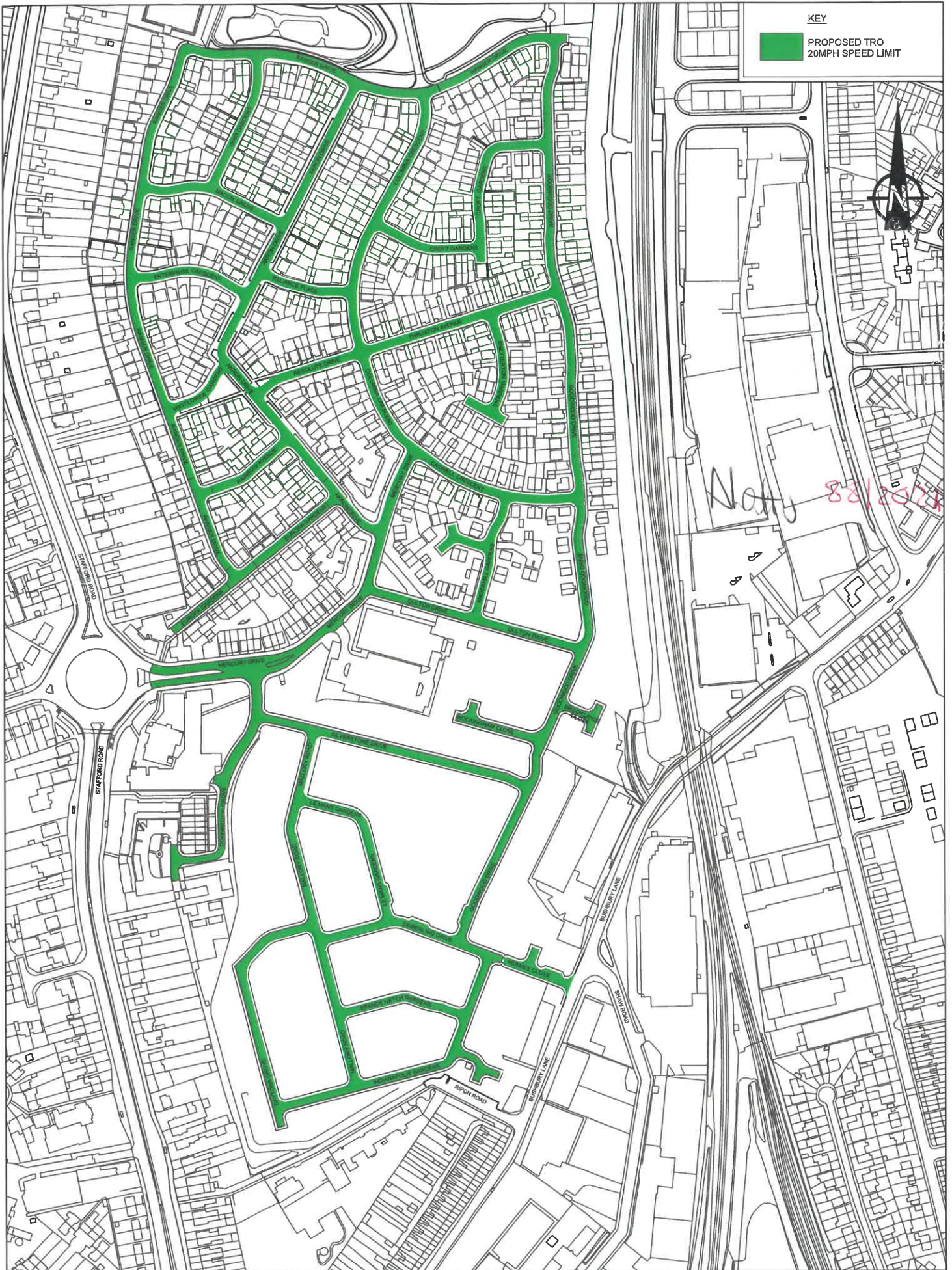
