## **PUBLIC NOTICE**

**NOTICE IS HEREBY GIVEN** that on 16 February 2021 Wolverhampton City Council made the following Orders under Sections 1, 1(1), 2, 2(1), 3, 84 and 124(1)(d) of the Road Traffic Regulation Act 1984. The effect of the Orders which come into operation on 19 February 2021 are as follows:

- 1. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 9) ORDER 2020

  This order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day.
  - This order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Mill Street and Hickman Road.
- THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 4) ORDER 2020
   This Order will prohibit any vehicle to:
  - (i) wait at any time on any day in parts of Donnington Grove, Silverstone Drive, Oulton Drive, Knockhill Gardens, Mercury Drive, Akron Drive, Cadwell Crescent, Hermes Close, Ranger Drive, Goodwood Drive, Croft Gardens,
  - Snetterton Gardens, Mayflower Gardens, Resolute Drive, Rockingham Close and Brooklands Close;

    (ii) wait at any time on any day and to load and unload at any time on any day in parts of Ripon Road, Bushbury Lane,
    Hermes Close, Shaw Road, Daytona Grove, Mallory Road and Indianapolis Gardens;
  - (iii) wait between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Indianapolis Gardens;
     (iv) wait for a period longer than 30 minutes with no return within 2 hours between 8.00am to 4.00pm Monday to
  - Friday in parts of Ripon Road; and
    (v) stop between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday on school entrance markings in parts of Ripon Road and Indianapolis Gardens.
- 3. THE WOLVERHAMPTON CITY COUNCIL (HERMES CLOSE) (PROHIBITION OF DRIVING FOR ALL MOTOR VEHICLES) ORDER 2020

This Order will prohibit any motor vehicle to proceed along Hermes Close from a point 53 metres west of the western kerb line of Bushbury Lane for a distance of 2 metres in a western direction. This Order shall not apply to cycles or emergency vehicles.

- 4. THE WOLVERHAMPTON CITY COUNCIL (GOODYEAR ESTATE) (20 MPH SPEED LIMIT) ORDER 2020
- No person shall drive any vehicle with a maximum speed exceeding 20 miles per hour along Hermes Close, Indianapolis Gardens, Daytona Grove, Mallory Road, Brands Hatch Gardens, Seiberling Drive, Le Mans Gardens, Silverstone Drive, Donnington Grove, Goodwood Drive, Rockingham Close, Oulton Drive, Knockhill Gardens, Mercury Drive, Cadwell Crescent, Columbia Crescent, Thruxton Avenue, Snetterton Gardens, Resolute Drive, Reliance Place, Croft Gardens, Ranger Drive, Ohio Gardens, Macon Grove, Enterprise Crescent, Mayflower Gardens, Rainbow Avenue, Europa Gardens, Akron Drive, Brooklands Close.

Any person who wishes to question the validity of the Order(s), on the ground(s) that it is not within the powers of the relevant section of the Act or on the ground(s) that any requirement of those sections of the Act or of Parts I to III of Schedule 9 to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 16 February 2021 make application for the purpose to the High Court.
