**NOTICE IS HEREBY GIVEN** that on 29 November 2022 Wolverhampton City Council made the following Orders under Sections 1, 2, 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The effect of the Orders which comes into operation on 2nd December 2022 is as follows:

- 1. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 3) ORDER 2022
  - (i) wait between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Newbridge Crescent; and
  - (ii) stop between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday on school entrance markings in parts of Newbridge Crescent and Newbridge Avenue; and
  - (iii) wait at any time on any day and to load and unload at any time on any day in parts of Newbridge Crescent, Marlborough Gardens, Pineways Drive, The Courtlands, Newbridge Avenue and The Lindens.
- THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 4) ORDER 2022

This Order will prohibit any vehicle to:

- (i) wait for a period longer than 30 minutes with no return within 2 hours 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Regis Road; and
   (ii) wait in a disabled person's parking place between 8.00am and 5.00pm Monday to Friday unless there is displayed
- on that vehicle in the relevant position a valid disabled person's badge for a longer period than 30 minutes with no return within 1 hour in parts of Regis Road, provided that the vehicle immediately before or after the act of parking has been or is about to be driven or used by the person to whom the badge has been issued or as the cause may be, used for the carrying of disabled person(s) as passengers(s).

Existing traffic regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

3. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 5) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day in parts of Grotto Lane, Crane Terrace and Aldersley Road.

4. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 6) ORDER 2022

This Order will prohibit any webiale to wait at any time on any day in parts of Dynatell Lang. Dynatell Road, Carrebreek.

This Order will prohibit any vehicle to wait at any time on any day in parts of Dunstall Lane, Dunstall Road, Gorsebrook Road and Carter Road.

THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING

This Order will prohibit any vehicle to wait at any time on any day in parts of Aldersley Avenue and Green Lane.

5. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 8) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Foley Avenue, Foley Drive and Wood Road.

7. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 9) ORDER 2022

This Order will prohibit any vehicle to:

- (i) wait between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Marsh Lane; and
- (ii) wait at any time on any day and to load and unload at any time on any day in parts of Marsh Lane and St Annes Road.
- THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 10) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day in parts of Crossland Crescent, Harwin Close, Kendal Rise and Blackburn Avenue.

. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 11) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Hordern Road, Farndale Avenue and Crowther Road.

Existing traffic regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

10. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 16) ORDER 2022

This Order will prohibit any vehicle to wait at any time on any day in parts of Oxford Street, Hare Street, Chapel Street and Lester Street.
