NOTICE IS HEREBY GIVEN that on 14 November 2023 Wolverhampton City Council made the following Orders under Sections 1, 2, 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The effect of the Orders which comes into operation on 17 November 2023 is as follows:

1. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 3) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of Clifton Street.

Existing Traffic Regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

2. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Hessian Close, Birmingham New Road Service Road and Shaw Road.

3. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 8) ORDER 2023

This Order will prohibit any vehicle to:

- (i) wait at any time on any day in parts of Church Street (Heath Town); and
- (ii) wait between 8.00am to 9.30am and 4.30pm to 6.30pm Monday to Saturday in parts of Church Street (Heath Town).

Existing Traffic Regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

4. THE WOLVERHAMPTON CITY COUNCIL (CITY CENTRE) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2023

This Order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Wulfruna Street;
- (ii) wait for a period longer than 5 minutes with no return within 1 hour between 6.00am and midnight in parts of Wulfruna Street; and
- (iii) wait between 6.00am and 11.00pm on any day in the loading area unless such waiting is necessary to enable goods to be loaded on or unloaded from the vehicle in connection with adjoining trade or business premises in parts of Wulfruna Street.

Existing Traffic Regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

Any person who wishes to question the validity of the Orders, on the grounds that it is not within the powers of the relevant section of the Act or on the ground that any requirement of those sections of the Act or of Parts I to III and IV of Schedule 9

to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 14 November 2023 make an application for the purpose to the High Court.
