

# PUBLIC NOTICE

**NOTICE IS HEREBY GIVEN** that on 7 September 2021 Wolverhampton City Council made the following Orders under sections 1, 2 and 124(1) (d) of the Road Traffic Regulation Act 1984. The effect of the Orders which come into operation on 10 September 2021 are as follows:

**1. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 3) Order 2021**

This order will prohibit any vehicle to wait at any time on any day in parts of Limes Road, Grange Road and Cornwall Road.

**2. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 4) Order 2021**

This order will prohibit any vehicle to wait at any time on any day in parts of Earlswood Crescent, Clewley Drive and The Droveaway.

**3. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 5) Order 2021**

This order will prohibit any vehicle to wait at any time on any day in parts of Alameda Gardens and Sandy Lane.

**4. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 7) Order 2021**

This order will prohibit any vehicle to wait at any time on any day in parts of Kyle Close and Oxley Moor Road.

**5. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 8) Order 2021**

This order will prohibit any vehicle to wait at any time on any day in parts of Froyle Close and Regis Road.

**6. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 9) Order 2021**

This order will prohibit any vehicle to wait at any time on any day in parts of Cranmore Road.

**7. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 10) Order 2021**

This order will prohibit any vehicle to:

- (i) wait between 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8.00am to 9.15am and 2.30pm to 4.30pm Monday to Friday in parts of Chester Avenue; and
- (ii) wait at any time on any day and to load and unload between 8.00am to 9.15am and 2.30pm to 4.30pm Monday to Friday in parts of Blackburn Avenue and Chester Avenue.

**8. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 11) Order 2021**

This order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Paget Road; and
- (ii) wait at any time on any day and to load and unload at any time on any day in parts of Paget Road, Clark Road and Hatton Road.

**9. The Wolverhampton City Council (Tettenhall) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 12) Order 2021**

This order will prohibit any vehicle to wait at any time on any day in parts of Codsall Road and Tynninghame Avenue.

Any person who wishes to question the validity of the Order(s), on the ground(s) that it is not within the powers of the relevant section of the Act or on the ground(s) that any requirement of those sections of the Act or of Parts I to III of Schedule 9 to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 7 September 2021 make application for the purpose to the High Court.
