

# PUBLIC NOTICE

**NOTICE IS HEREBY GIVEN** that on 6 June 2023 Wolverhampton City Council made the following Orders under Sections 1, 2, 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The effect of the Orders which comes into operation on 9 June 2023 is as follows:

**1. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 1) ORDER 2023**

This Order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Waterdale, Compton Road West, Linden Lea and Ash Hill;
- (ii) wait at any time on any day and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Compton Road West and Linden Lea; and
- (iii) wait between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Waterdale and Linden Lea.

Existing Traffic Regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

**2. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2023**

This Order will prohibit any vehicle to:

- (i) stop between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday on school entrance markings in parts of Compton Road; and
- (ii) stop between 8am to 9.30am and 3pm to 4.30pm except buses in parts of Compton Road.

Existing Traffic Regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

**3. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 1) ORDER 2023**

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Collingwood Road, Bushbury Lane, Somerford Gardens and Hatherton Gardens.

**4. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2023**

This Order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Cannock Road, Old Fallings Lane and Park Lane;
- (ii) wait at any time on any day and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Cannock Road; and
- (iii) wait between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday except Bank Holidays and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday except Bank Holidays in parts of Old Fallings Lane.

Existing Traffic Regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

**5. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 3) ORDER 2023**

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of The Riddings and Croft Lane.

**6. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 4) ORDER 2023**

This Order will prohibit any vehicle to:

- (i) stop between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday on school entrance markings in parts of Shelley Road; and
- (ii) wait at any time on any day and to load and unload between 8am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Shelley Road, Burns Avenue and Browning Crescent.

**7. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 5) ORDER 2023**

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Goodyear Avenue, Jenks Avenue and Whitgreave Avenue.

**8. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 6) ORDER 2023**

This Order will prohibit any vehicle to wait at any time on any day in parts of Deyncourt Road and Wimborne Road.

**9. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 7) ORDER 2023**

This Order will prohibit any vehicle to wait at any time on any day in parts of Lymer Road.

Any person who wishes to question the validity of the Orders, on the grounds that it is not within the powers of the relevant section of the Act or on the ground that any requirement of those sections of the Act or of Parts I to III and IV of Schedule 9 to the Act or any regulation under the said Part III has not been complied with may, within six weeks of 6 June 2023 make an application for the purpose to the High Court.
