NOTICE IS HEREBY GIVEN that on 22 September 2020 Wolverhampton City Council made the following Orders under Sections 1, 2 and 124(1)(d) of the Road Traffic Regulation Act 1984. The effect of the Orders which come into operation on 25 September 2020 are as follows:

1. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 3) ORDER 2019

This Order will prohibit:

- (i) any vehicle to wait in a disabled person's parking place unless there is displayed on that vehicle in the relevant position a valid disabled person's badge for a longer period than 3 hours with no return within 1 hour on any day in parts of Park Road East and Park Road West;
- (ii) any vehicle to wait at any time on any day in parts of Park Road West;
- (iii) any vehicle to wait for a period longer than 30 minutes with no return within 1 hour between 8am to 10am and 2pm to 4pm, Monday to Friday in parts of Park Road East;
- (iv) any vehicle to wait for a period longer than 3 hours with no return within 2 hours between 8am and 6pm, on any day in parts of Park Road West;
- (v) any vehicle to wait for a period longer than 4 hours with no return within 2 hours between 9am and 2pm, Monday to Friday in parts of Park Road East and Park Road West.

2. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2019

This Order will prohibit any vehicle to wait at any time on any day in parts of Church Hill Road and Clifton Road.

3. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 16) ORDER 2019

This Order will prohibit any vehicle to wait at any time on any day in parts of Whistler Grove and Carlyle Road.

4. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES)(AMENDMENT NO 12) ORDER 2019

This Order will prohibit any vehicle to wait at any time on any day in parts of Sunbeam Street.

5. THE WOLVERHAMPTON CITY COUNCIL (WEDNESFIELD) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2020

This order will prohibit any vehicle to wait:

- (i) at any time on any day in parts of Hazelwood Drive;
- (ii) between 8am to 9.30am and 2.30pm to 5pm, Monday to Friday in parts of Hazelwood Drive.
