

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that Wolverhampton City Council proposes to make the following Order under Sections 1, 2, 84 and 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers. The effect of the Order is as follows:

1. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2025

This Order will prohibit any vehicle to:

- (i) wait at any time on any day in parts of Woodcote Road;
- (ii) wait at any time on any day and load and unload at any on any day in parts of Woodcote Road;
- (iii) stop between 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday on school entrance markings in parts of Woodcote Road; and

Existing Traffic Regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

2. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (WOODCOTE ROAD AREA) (20 MPH SPEED LIMIT) ORDER 2025

This Order will prohibit any vehicle with a maximum speed exceeding 20 miles per hour on the lengths of roads specified in the Schedule:

| 4. | Wincote Drive | From its junction with Woodcote Road for its entirety. |
| 5. | Woodcote Road | From its junction with Wood Road for its entirety including its northern and southern cul-de-sacs. |
