- (v) The tickets for use of the Parking Places;
- (vi) Further details of the location and extend of the Parking Places;
- (vii) The enforcement provisions relating to the use of the Parking Places and which will remain in force and operation at the Parking Places at all times;
- (viii) The terms and conditions of use of the Parking Places, which users of the Parking Places will be required to observe and comply with at all times whilst they are in the Parking Places entering or exiting the Parking Places

Existing Off-Street Parking Orders (Traffic Regulation Orders) will be revoked to the extent necessary to facilitate the provisions of this Order.
