

# PUBLIC NOTICE

**NOTICE IS HEREBY GIVEN** that Wolverhampton City Council propose to make the following Orders under Sections 1, 2 and 124(1)(d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984. The effect of the Orders is as follows:

**1. THE WOLVERHAMPTON CITY COUNCIL (TETTENHALL) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 1) ORDER 2022**

This Order will prohibit any vehicle to wait at any time on any day in parts of Slade Road, Patshull Avenue and Harrowby Road.

**2. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 1) ORDER 2022**

This Order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Compton Road, Marchant Road, Westland Road, Westland Avenue, Merridale Avenue, Merridale Crescent and Merridale Avenue; and
- (ii) wait between 8.00am to 9.30am and 2.30pm to 6.30pm Monday to Friday and to load and unload between 8.00am to 9.30am and 2.30pm to 6.30pm Monday to Friday in parts of Compton Road; and
- (iii) wait between 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday and between 10.30am to 2.30pm and 6.00pm to 8.00pm Sunday and to load and unload between 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday and between 10.30am to 2.30pm and 6.00pm to 8.00pm Sunday in parts of Compton Road; and
- (iv) wait between 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday and to load and unload between 8.00am to 9.30am and 2.30pm to 4.30pm Monday to Friday in parts of Compton Road;

Existing traffic regulation Orders will be revoked to the extent necessary to facilitate the provisions of this Order.

**3. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 2) ORDER 2022**

This Order will prohibit any vehicle to wait at any time on any day in parts of Wakeley Hill and Butts Road.

**4. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 3) ORDER 2022**

This Order will prohibit any vehicle to wait at any time on any day in parts of Sycamore Drive.

**5. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 7) ORDER 2022**

This Order will prohibit any vehicle to wait at any time on any day in parts of Dudding Road, Wolverhampton Road East, Park Hall Road and Greenly Road.

**6. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 4) ORDER 2022**

This Order will prohibit any vehicle to wait at any time on any day in parts of Holly Grove.

**7. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 5) ORDER 2022**

This Order will prohibit any vehicle to wait at any time on any day in parts of Uplands Drive and Uplands Avenue.

**8. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 6) ORDER 2022**

This Order will prohibit any vehicle to wait at any time on any day in parts of Hazel Road and Victoria Road.
