

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that Wolverhampton City Council proposes to make the following Orders under sections 1, 2 and 124(1) (d) of the Road Traffic Regulation Act 1984. The effect of the Orders is as follows:

1. The Wolverhampton City Council (Bilston) (Prohibition and Restriction of Waiting & Street Parking Places) (Amendment No 5) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in parts of Merstone Close and Wolverhampton Street.

2. The Wolverhampton City Council (Penn) (Prohibition & Restriction of Waiting & Street Parking Places) (Amendment No 13) Order 2021

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Langley Road and Fareham Crescent.

3. The Wolverhampton City Council (Tettenhall) (Prohibition & Restriction of Waiting & Street Parking Places) (Amendment No 13) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in parts of Sandy Lane, Aldersley Road, Lower Street, Codsall Road and Lothians Road.

4. The Wolverhampton City Council (Wednesfield) (Prohibition & Restriction of Waiting & Street Parking Places) (Amendment No 8) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in parts of Moreton Road and Bushbury Lane.

5. The Wolverhampton City Council (Wednesfield) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 9) Order 2021

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Victoria Road and Bickford Road.

6. The Wolverhampton City Council (Wednesfield) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 11) Order 2021

This Order will prohibit any vehicle to wait at any time on any day in parts of Fordhouse Road, Elston Hall Lane, Three Tuns Lane, Wood Lane, Sherborne Road, Ringwood Road, Stanley Road, Purcell Road, and Whetstone Road.

7. The Wolverhampton City Council (Wednesfield) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 12) Order 2021

This Order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Helming Drive, Friesland Drive and Sigmund Close; and
- (ii) wait at any time on any day in parts of Friesland Drive.

8. The Wolverhampton City Council (Wednesfield) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 13) Order 2021

This order will prohibit any vehicle to:

- (i) wait at any time on any day and to load and unload at any time on any day in parts of Lewis Grove and Lichfield Road; and
- (ii) wait at any time on any day in parts of Lichfield Road.

9. The Wolverhampton City Council (Wednesfield) (Prohibition and Restriction of Waiting and Street Parking Places) (Amendment No 14) Order 2021

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Dace Road and Wednesfield Way.
