

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that Wolverhampton City Council propose to make the following Orders under Sections 1, 2, 124(1)(d) of the Road Traffic Regulation Act 1984. The effect of the Orders is as follows:

1. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 4) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of Gosport Close, Bedford Street and Stowheath Lane.

2. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 5) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of Green Lanes, Prouds Lane and Green Park Avenue.

3. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 6) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of Dilloways Lane.

4. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 7) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of Addison Place, Kempthorne Road, Lunt Road and Lunt Place.

5. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 8) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of King Street, Bank Street and Kirby Close.

6. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 10) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of Slim Avenue.

7. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 11) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of Hincks Street and Ettingshall Road.

8. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 12) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day and to load and unload at any time on any day in parts of School Drive and Rocket Pool Drive.

9. THE WOLVERHAMPTON CITY COUNCIL (BILSTON) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 14) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of Brierley Lane and Wesley Street.

10. THE WOLVERHAMPTON CITY COUNCIL (PENN) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (AMENDMENT NO 6) ORDER 2023

This Order will prohibit any vehicle to wait at any time on any day in parts of Wootton Road and Coppice Road.
