

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that Wolverhampton City Council proposes to make the following Order under Section 84 of the Road Traffic Regulation Act 1984. The effect of the Order is as follows:

1. THE WOLVERHAMPTON CITY COUNCIL (CHURCH HILL, PENNWOOD LANE, SEDGLEY ROAD AND VICARAGE ROAD) 20 MPH SPEED LIMIT ORDER 2023

No person shall drive any vehicle with a maximum speed exceeding 20 miles per hour on the lengths of roads specified in the Schedule below:

| 1. Church Hill | 8 metres from the northern kerb line of Vicarage Road in a northern direction to its junction with Sedgley Road. |
| 2. Pennwood Lane | 10 metres from the eastern kerb line of Sedgley Road to its junctions with Church Hill and Sedgley Road. |
| 3. Sedgley Road | 26 metres to its junction with CotSDale Road in a northern direction to its junction with Pennwood Lane. |
| 4. Vicarage Road | 16 metres from the eastern kerb line of Church Hill in an eastern direction. |

2. THE WOLVERHAMPTON CITY COUNCIL (CHURCH HILL AND SEDGLEY ROAD) PROPOSED TRAFFIC CALMING MEASURES

Under the provisions of the Highways Act 1980 as amended by the Road Traffic Act 1991 the Wolverhampton City Council also proposes to install Traffic Calming Measures as follows:

SCHEDULE 1

Schedule of vertical deflections

Location	Type of Traffic Calming
Church Hill - Flat top road hump 72 metres from the western kerb line of Sedgley Road in a western direction.	75mm high flat top road hump
Church Hill - Speed cushions 6 metres from the western kerb line of Sedgley Road in a western direction.	75mm high speed cushions
Sedgley Road - Flat top road hump 67 metres from the southern kerb line of Pennwood Lane in a southern direction.	75mm high flat top road hump
Sedgley Road - Speed cushions 150 metres from the southern kerb line of Pennwood Lane in a southern direction.	75mm high speed cushions
